### 477th Fighter Group welcomes new commander

Piffarerio accepted the reins of leadership from Col. Tyler Otten who will move on to be the Mo-

bilization Assistant to the 11th Air Force Commander here at Joint Base Elmendorf-Richardson.

Under Otten's command, the group's Airmen weathered difficult financial challenges including furloughs and the government shutdown, while continuing to

accomplish the mission of training citizen airmen to execute the F-22 mission with their active duty partners in the 3rd Wing. The unit was one of nine Air Force Reserve units to earn the Air Force Outstanding Unit Award in 2014.

"It has been an honor to serve the men and women of the 477th Fighter Group as their commander for the last two and a half years. I have been repeatedly amazed at their capabilities and commitment to the mission," said Otten. "I am looking forward to watching them continue to do great things under Colonel Piffarerio's leadership."

Piffarerio came to the came 477th Fighter Group in August 2007 from Nellis AFB, Nevada where he served as an F-22 operational test pilot. While in the 477th FG Piffarerio served as Flight Commander, Weapons Officer, Assistant Director of Operations and Commander of the 302nd Fighter



Squadron. Most recently, Piffarerio served as the 477th Fighter Group Deputy Commander.

"The 477th FG has a tremendous heritage and history of incredible airmen," said Piffarerio. "I look forward to leading this organization to great heights and working with the men and women of the 477th FG and our partners in the 3 WG."

> During the ceremony Brig. Gen. Richard Scobee, 10th Air Force commander lauded Otten's accomplishments as commander and said "Col. Piffarerio has been a member of the 477th Fighter Group family since 2007; he knows the organization and how to continue to

make the group successful."

Piffarerio is native of Colorado and received his commission from the United States Air Force Academy in 1994. Piffarerio began his career flying F-15E's before being selected as initial cadre to test the F-22 during follow-evaluations. In 2011, Piffarerio was the first Air Force pilot to reach 1,000 flight hours in the F-22 Raptor.

In 1990, Pauline Trost in collaboration with Zachary Fisher began moving forward with the Fisher House concept. In 1991, the first Fisher House opened its doors at Bethesda, MD. To date, 64 total Fisher Houses donated by the Fisher family and Fisher House Foundation are open on the grounds of major military and VA medical centers.

Alaska Fisher House is a temporary residence that provides the comforts of home at no charge for service members, veterans, and their family members while receiving medical care in the Anchorage area. It opened its doors in December 2011.

Members of the 477th Fighter Group have been supporting our Alaska Fisher House for nearly three and a half years by providing dinner on the first Wednesday of every month. I want to thank each and every one of you who have donated food, supplies, and of course, your time to offer a home-cooked meal every month. **PRINT ORDERS WITH SSNS:** Social security numbers (SSN) are no longer masked on orders printed from AROWS-R. When you print orders from AROWS-R, the default print WILL display an SSN unless you take extra steps to mask it. The orders you turn in for military pay and travel vouchers must have SSN.

**AIRLINE RESERVATIONS, RENTAL CARS AND OPTIONAL SERVICES:** For temporary duty (TDY) travel you must use a government-contracted commercial travel office (SATO for example) to arrange for air and rental car transportation. Rental car authorization should be stated in orders. The individual who is authorized the rental car can be reimbursed for the rental and fuel. If someone other than the authorized user pays for fuel, that person cannot be reimbursed. By using SATO the government rate provides rental car insurance coverage. You should not acquire additional insurance, roadside assistance coverage, GPS service, or satellite radio service. If you do get optional coverage or services, the extra cost will not be reimbursed. Also, rental carwash costs are not reimbursable.
